For example, if a request for consultations is issued for a new dispute (this is usually the first document issued in a dispute) and a report has not yet been issued, TradeLawGuide will indicate that a panel report is pending. The substantive content of the request for consultations will determine which provisions are indexed in this tool. The relevant provisions are modified as necessary as subsequent dispute settlement documents are issued in the dispute.

The default display option is "by Agreement/Provision". This option lists all of the WTO agreements and instruments that are being cited in dispute settlement documents.
